LivGenerations Agritopia Residents and Family Members of The Terrace and Courtyard Buildings,

We would like to remind you of the lifestyle modifications that were made last week. While we know it is a relief to be vaccinated, there are residents in our community awaiting their final vaccine. Additionally, we are still learning about the impact of the new strains and the full efficacy of the vaccine. It is wise to continue forward with caution. As the greater Phoenix-area comes closer to herd immunity and as we learn more about the full scope of vaccine protection, we will continue to modify our policies and procedures.

Visitors:

Vaccinated Visitors –

- Fully vaccinated visitors (14 days after final dose) who show proof of vaccination may visit without a current negative COVID-19 test.
- Visitors must wear a mask when moving through the community but once in the private apartment home may remove their mask if resident and visitor is double vaccinated.
- Vaccinated visitors may gather in small groups in the apartment home if all parties are vaccinated. They are not allowed to use our common spaces at this time.
- Vaccinated visitors may eat in the apartment home if their resident is also vaccinated.
- At this time, no visitors may eat in The Crave.
- Please adhere to visiting hours between 8 a.m. and 7 p.m.

Non-Vaccinated Visitors – (Designated Visitors)

- Follow current guidelines for a negative COVID-19 within four days of the visit.
- Limited to two visitors (if non-vaccinated) in apartment homes at a time, up to 4 hours.
- Must wear a mask at all times, even when in the apartment home of the resident.
- At this time, no visitors may eat in The Crave.
- Please adhere to visiting hours between 8 a.m. and 7 p.m.

Non-Vaccinated, Non-COVID Test Visitors — (Outdoor Visits)

- Outdoor visits will resume for visitors without COVID tests.
- Limit 1 visit per week for 30 minutes.
- Limit 2 people per visit. No children under 18.
- Appointment required please contact the front desk.

Mask Use:

- Until further notice the use of masks is mandatory at all times when outside of private apartment homes regardless of vaccination status.
- Masks may only be removed during dining.
- While the CDC has released guidelines saying it is safe to congregate with other vaccinated people without masks, our entire community is not yet fully vaccinated. We will examine the policy and wait to hear from the Arizona Department of Health Services and will modify as appropriate.

Vibrant Living:

- Group activities are back on. Residents must wear masks and social distance when possible.
- Entertainers will be allowed. All must pass an in-house RAPID test if not double vaccinated. Entertainers will wear a mask until the performance starts and will keep social distance from residents and employees.
- Full bus and outings may resume. Watch for upcoming events on the Vibrant Living schedule.

Dining:

- Full dining services are back. Meal plans are back in effect.
- Charges for wine, beer and alcohol in the dining room will resume.
- Room service will still be available, but delivery fees may apply.
- The Bistro will once again provide beverages for your enjoyment.

Off-campus Mobility:

- Residents may once again move freely off campus.
- The driver or family member who is providing transportation must show proof of negative COVID-19 test, vaccination or pass an in-house RAPID test if available. Please make an appointment.
- Staying off-campus overnight for non-vaccinated residents will require apartment quarantine for 10 days or a test out at 7 days. A vaccinated resident will not need to quarantine.

Non-Vaccinated Residents:

- Daily temperature checks and weekly testing will still occur.
- If COVID-19 positive, resident will be required to quarantine as usual.

Today, March 11, we have no (0) residents and no (0) team members diagnosed with active cases of COVID-19.
